***EVENTING DERBY (\$100):** Scoring: A combined score of dressage test penalty points & jumping test penalty points. Jumping Test will be a mix of show jumps & xc jumps. Courses will be measured with an optimum time. Penalties are as follows: Rails (4pp) Refusals (10pp), Time Penalties (.4pp/second), & closest to optimum time without faults wins ties. **Vests and medical armbands or bracelets required.**
